Players violating the above rule will be suspended and/or banned from the League with **no refund of fees**.

### RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I accept that hockey is a sport with inherent risks and that participation in the sport may result in my injury. I AGREE TO ACCEPT THE RESPONSIBILITY FOR MY OWN SAFETY.

In consideration of my membership and participation in the Molson Hockey League, I HEREBY AGREE AS FOLLOWS:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the Molson Sportsmen Hockey League, League organizers, team captains, referees, the Corporation of the City of Barrie and the Corporation of the Township of Essa (all of whom are herein after collectively referred to as the "League");
2. TO RELEASE THE LEAGUE from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in the League and League sponsored activities, due to any cause whatsoever, including negligence on the part of the League;
3. TO HOLD HARMLESS AND INDEMNIFY THE LEAGUE from any and all liability for any property damage or personal injury to any third party, resulting from my participation in the League and League sponsored activities;
4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.

I have read and understood this Agreement prior to signing it, and I am aware that by signing this Agreement I am waiving certain legal rights, which I or my heirs, next of kin, executors, administrators and assigns may have against the League.
